In addition, the general understanding of any "publication, video, and internet consent and release agreement" is incorporated in this release including: no monetary considerations, photo, video or verbal statements may be used now and in the subsequent years as the program deems fit; is binding upon heirs and/or future legal representatives.

AMATEUR Eligibility Questionnaire

I. AMATEUR ELIGIBILITY

YES x _____ Any Over All High Point or Championship - Cumulative Year-End Award with 5 or more eligible participants in WSVRHA Intermediate Division or a Division that includes going down the fence or roping at any WSVRHA, SHOT, ASHA, NVRHA or similar organization.

NO Any Reserve High Point or Reserve Championship - Cumulative Year-End Award with 5 or more eligible participants in WSVRHA Intermediate Division or a Division that includes going down the fence or roping at any WSVRHA, SHOT, ASHA, NVRHA or similar organization.
